The Exhibitor further releases the Conference and its officers, directors, employees and agents from all claims, demands, rights or causes of actions, present or future, known, anticipated or unanticipated, resulting from or arising out of or incident to the Exhibitor's use of any facilities at the Georgia World Congress Center or as result of or incident to the Event.
